ULTRA SHORT-TERM DEBENTURES
(FOR COVID-19 PREVENTION AND CONTROL)**

The announcement is made by China Longyuan Power Group Corporation Limited* (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 17 May 2019 on the poll results of the 2018 annual general meeting of the Company in relation to the approval of the issuance of debt financing instruments of non-financial enterprises by the shareholders of the Company.

The Company has completed the issuance of ultra short-term debentures (for COVID-19 prevention and control) (the “**Ultra Short-term Debentures (for COVID-19 Prevention and Control)**”) of the Company on 6 March 2020. The aggregate issuance amount of the Ultra Short-term Debentures (for COVID-19 Prevention and Control) was RMB0.5 billion with a term of 270 days, nominal value per unit of RMB100 and coupon rate of 2.45%. The interest shall be accrued from 6 March 2020.

Shanghai Pudong Development Bank Co., Ltd. was the lead underwriter for the public offering of the Ultra Short-term Debentures (for COVID-19 Prevention and Control). The proceeds raised from the Ultra Short-term Debentures (for COVID-19 Prevention and Control) will be mainly used for the replenishment of working capital of Hubei Longyuan New Energy Co., Ltd. and Longyuan Baokang Wind Power Generation Co., Ltd., the project companies of the Company and repayment of the Group’s entrusted loans.

This announcement does not constitute, or form part of, an offer or invitation, or solicitation or inducement of an offer, to subscribe for or purchase any of short-term debentures or other securities of the Company, nor is this announcement distributed to invite offers for any securities of the Company.
